Building

High Priority

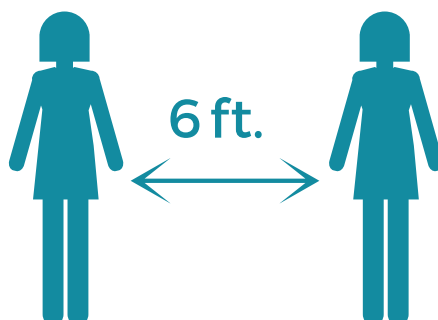
- ✓ Ensure a minimum of 6 feet between people at all times, with the exception of the client & worker
- ✓ Post proper handwashing signage in rest areas
- ✓ Everyone wear a mask or face covering at all times (if able): <https://mibeautypros.org/diy-mask>
- ✓ Hourly sanitation of common areas
- ✓ Hand sanitizer at all workstations and entryway
- ✓ Daily screening of symptoms for all who enter the building:
 - ❓ Have you had a cough, fever (99.9°F /37.8°C or more), shortness of breath, or been around anyone exhibiting these symptoms within the past 14 days?
 - ❓ Are you living with anyone who is sick or quarantined?
 - ❓ Do you have these symptoms: muscle aches, headache, sore throat, runny nose, chest pain, diarrhea, nausea, or vomiting?

Above & Beyond

- ✓ Acrylic dividers at reception area or anywhere social distancing cannot happen
- ✓ Remove all non-essential decor & furniture
- ✓ Close waiting areas
- ✓ Curbside pickup for retail
- ✓ Use contactless payments when possible
- ✓ Allow only workers to touch retail products

Workers

High Priority

- ✓ Wear a face shield or goggles when performing services where clients cannot wear masks or when liquids can splatter
- ✓ Prior to disinfecting, work areas should be cleaned with soap and water. Follow disinfectant contact time to thoroughly destroy all pathogens (typically 2-10 minutes) <https://www.epa.gov>
- ✓ Use of EPA approved disinfectants, clean work areas following sanitation practices contained in Michigan Admin Rules 339.6031, 339.6033, 338.2171, 338.2173, 338.2176, 338.2179, 338.2179a, 338.2179c, and 338.2179d
- ✓ Proper hand washing practice between each client
- ✓ Dispose of Single-Use Items
- ✓ Linens and supplies are laundered and changed between every guest
- ✓ Schedule enough time between appointments to accommodate new guidelines
- ✓ Workers should only touch the client when performing the service, no hugs, handshakes, or any unnecessary touching
- ✓ Keep work surfaces free of all items except those being used for current client
- ✓ Maintain social distancing and sanitation in break rooms

Above & Beyond

- ✓ Limit services to only what is essential, for example hand massage, pre-washing head massage
- ✓ Workers arrives in freshly laundered attire
- ✓ Change smock between each client
- ✓ Workers will keep hair pulled back, or wear head covering
- ✓ Virtual consultations
- ✓ Regularly clean air ducts
- ✓ Group workers by shift to reduce exposure
- ✓ Launder work clothing daily and shower immediately upon returning home from the establishment

Guests

High Priority

- ✓ Use floor stickers and signage to promote social distancing
- ✓ POS Stations sanitized after every transaction
- ✓ Use 1 entrance into building
- ✓ Signage to explain new policies and procedures for clients
- ✓ Maintain accurate appointment records with date, time, name, and contact information to assist in contact tracing
- ✓ Removal of non-essential amenities and self-service stations

Above & Beyond

- ✓ Appointment only, no walk-ins
- ✓ Ask clients to come with washed hair and clean clothes
- ✓ Clients wait in the car until appointment time
- ✓ Limit the number of items clients brings to appointments
- ✓ Only clients receiving services are allowed in the building, minors accompanied by 1 adult

Specialty Areas

High Priority

- ✓ Ensure salon and barber chairs are a minimum of 6 feet apart from center to the next center of chair as referenced under Mich. Admin Rule 339.6041
- ✓ For pedicure services, jetted tubs without liners will need to have all parts removed and disinfected. In addition, run the jets for 10 minutes with proper disinfectant

Above & Beyond

- ✓ Temporarily prohibit the return of purchased products and merchandise
- ✓ Use a disposable liner for each pedicure service

What To Do After A Confirmed Case

High Priority

- ✓ Immediately isolate and seek medical care for anyone who develops symptoms
- ✓ Shutdown area for deep sanitation and disinfection
- ✓ Contact the local health department and discuss your records

Above & Beyond

- ✓ If testing is available, test all suspected infections and exposures

Stay home if you feel unwell or show symptoms



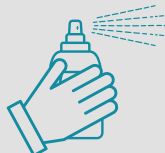
Avoid touching eyes, nose and mouth
